Business Leaders' full fibre connection



Business Leaders' input generated one of the liveliest round table discussions yet held around bringing pure fibre connectivity to Milton Keynes.

CityFibre, which wants to connect the city with a 'future-proof' data network, has been hosting meetings with MK Council to gauge the digital needs of city businesses. The latest, held at MK College's Silbury Campus in October allowed MK BLP members to have their say and hear from CityFibre's Marc Lough and Simon Pickering of project partner dbfb, about progress made.

Both agreed that Milton Keynes is playing catch-up with high data speeds and connectivity. According to Marc, a pure fibre network will allow MK to remain competitive regionally and nationally. CityFibre remains committed to 'fibre up' five UK cities by 2021 with 10 under consideration and Milton Keynes is a strong contender for funding. CityFibre has secured investment and MK Council is seeking Government funding, but Marc stressed that city businesses have to come forward and express their concerns that economic development is being constrained. Simon said that the role of groups like Business Leaders Partnership was crucial in getting that message across.

BLP members shared their views on current data connectivity in Milton Keynes. They included: 'Our whole business is currently based in the cloud, and when it goes down I start trembling!' and 'I had better connectivity on a cruise ship in the Antarctic than in Milton Keynes!'

There was strong support for better connectivity: 'A faster data network will support the local skills agenda, reach those currently without digital access and boost the digital transformation within our businesses' and, from a business that has already signed up to full fibre - 'It is fabulous!'

Members sought reassurance that real progress was being made between CityFibre and MK Council, with the future prosperity of the city at stake. Chair Philip Smith said MK BLP would do what it could and will be surveying members about data connectivity. The event closed with Marc thanking members for attending and adding: "This is the seventh one I have chaired and the first when everyone has said to me, 'what are YOU going to do about it'. And that's great because this is very much a collaborative exercise."

From burger bar to the House of Lords Dolar Popat's story is a lesson in the power of diversity

Businessman, philanthropist and advocate for community cohesion Lord Dolar Popat challenged MK Business Leaders members and guests when he spoke at a Quarterly Dinner in June.

"When I arrived in the UK in 1971 as a Ugandan Asian with no qualifications, little business experience and challenged by the English language, would you have given me a job? I suspect if we're being honest, the answer would have been no. But, and this is the crucial bit - I did have potential,"

Lord Popat, who worked as a waiter in a Wimpy bar while gaining night school accountancy gualifications, spoke passionately about diversity and the role it can play in business. He said the word diversity produces different reactions. "In the public sector it is championed with initiatives and legislation. In the private sector, particularly where there aren't large HR departments to worry about these things, diversity is a scary, offputting word like inclusion, accessibility and empowering that seems to mean more paperwork and less time to concentrate on profit," he said.

"The truth is in the middle and without diversity life would be very boring and in business it should be welcomed. People from different backgrounds have different opinions and ideas, and organisations themselves thrive on ideas."

"I'm not here with an intricate knowledge of Government "Whether young mothers returning to work, young diversity schemes, or to sell how businesses being more inclusive people without skills but a hunger in their eyes, or is good for society. I am here as a businessman saying that I someone like me from overseas, each has potential and think diversity helps make businesses more profitable because big ideas waiting to be unlocked." however good we are as individuals, there are hundreds of





ideas we have never considered.

o each other, he said. By 2020 there will be more than 24 billion onventionally accessed web addresses. Including the so-called dark levices connected in 'the internet of things', including driverless ars, will become a huge 'sensing system', and a target for hackers.

To coincide with the launch of MK BAA 2018, MK BLP chair Philip Smith produced an article for the October issue of Business MK. Here is a shortened version...

Now, more than ever, UK plc and MK plc need to sell their products, services and talents further afield.

When we leave the European Union we should maintain good trading relations with the countries within it and they will remain some of our biggest markets. But we cannot take that for granted. Following the EU Referendum there has been a change in attitudes towards finding and growing new markets beyond Europe and this brings fantastic opportunities for businesses in Milton Keynes.



Well before the EU vote MK Business Leaders Partnership identified countries where existing trade relationships with Milton Keynes could be strengthened and new ones forged. We began conversations with like-minded business interest groups and at the beginning of 2017 we announced a Memorandum of Understanding between MK Business Leaders and the British Business Group of Dubai and the Northern Emirates, opening the door for Milton Keynes companies. There has been significant interest among MK businesses, so far from the engineering, security and education sectors, and we have told businesses who want to trade there that we can put them in touch with people with local knowledge, contacts and experience.

We have also this year hosted a trade delegation from Shenzhen and our guests spoke warmly about reciprocal visits to China. We have also received the generous support of International Trade Secretary Dr Liam Fox and Iain Stewart MP, and while our trade 'mission, is encouraging new opportunities we are aware some businesses in MK are already doing great things abroad. That has prompted us to give the 2018 Milton Keynes Business Achievement Awards an 'International' theme, showcasing those companies selling the skills, industry and expertise of Milton Keynes around the world.
