# **2016 BLP events programme the best yet?**

## This year sees Milton Keynes Business Leaders host one of its most exciting and eclectic programmes of events.

BLP members have already made a visit to the Speaker's House at the Palace of Westminster (featured in this issue) and are looking forward to the MK Business Achievement Awards 2016 Dinner in March.

The quality of speakers earmarked for the Breakfast Briefings and Quarterly Dinners stand out with subjects close to home, including how to strengthen Milton Keynes' leisure and cultural offer; how community radio is 'keeping it local' with MKFM CEO Darren Dorrington; and looking at the role of Cranfield University in the region, with Professor Lynette Ryals Pro-Vice-Chancellor Cranfield University.

Widening the scope of Business Leaders' interests are talks and briefings covering UK infrastructure, British Military Intelligence and, a subject that remains a key focus for us – the Skills Agenda. And for the first time we will be going inside HMP Woodhill to discover if a better working relationship can be formed between business and the Prison Service.

Speakers due to visit include the Rt Hon Lord Adonis, Chairman of the National Infrastructure Commission; Lt Col Phaedra McLean of the British Army; Skills Minister Nick Boles MP; Bernard Donoghue, CEO of the Association of Leading Visitor Attractions; and the Rt Hon John Redwood MP, whose subject is as yet unannounced but likely to be thought provoking and topical.

BLP Chairman Philip Smith said: 'This is a really exciting line-up and I feel it is a measure of Business Leaders' reputation for attracting some stand-out speakers to Milton Keynes. Invitations to these events will follow as we go through the year and I expect demand for places will be high.'

January 2017 marks half a century since the 'new town' received its official designation. MK50 is the umbrella organisation for a year of golden anniversary festivities coordinated by Milton Keynes Council. Project Manager Lallie and Senior Heritage Officer Shane gave members an overview of the plans so far at a Breakfast Briefing and invited the business community to contribute. 'MK50 wants business on board,' said Lallie.

Shane said MK50 is not just about arts and culture, but how we make Milton Keynes a better place to live work and play. He said events like MK50, a bid for Capital of Culture 2023 and potentially gaining City Status should counter a sometimes negative perception of Milton Keynes.

'Supporting MK50 is not just philanthropy but about benefiting your business, through your employees' involvement and encouraging those with skills you need to relocate to Milton Keynes. We want the business sector to be involved in the strategic thinking around MK50 and I invite those interested in getting involved to contact us,' he said.

Philip Smith thanked Lallie and Shane and said, 'January 23, 2017 is an important milestone for Milton Keynes. So much has been achieved, including business success, over almost fifty years. We are pleased a team is coordinating celebrations and support the business community getting involved.'

# Business Leaders get sneak peek at IF:MK 2016

MK Business Leaders had an exclusive preview of the highlights planned for the IF: Milton Keynes International Festival 2016.

But they were told by festival director Monica Ferguson at a breakfast briefing that the unconfirmed part of the line-up was under a strict embargo. Monica said the biennial multiarts event in July will build on the success of previous festivals and the proposed programme includes elements that have proved popular in the past with a host of

new acts, artworks and events, some of them on an epic scale. What members and guests saw was impressive and should be truly spectacular.

IF continues to raise the bar for arts and culture in Milton Keynes said Monica and she invited Business Leaders members to get on board: 'Talk to us if you wish to take a role in the festival and about some of the business opportunities at IF. If we can continue to count on the support of the business community, it's going to be a hell of a ride in 2016.'

Philip Smith thanked Monica and her team for presenting what he said was a fascinating insight into what is planned and he is looking forward to IF. 'Clearly there are opportunities for business to get involved and I am sure we will want to hear more about them.'

### Let's celebrate a new way to fund the arts and culture scene

Good things come in twos and it just so happened that the speakers who closed another year of fascinating MK Business Leaders Partnership Breakfast Briefings talked about related subjects.

In November we got an overview of MK50, the ambitious project to mark Milton Keynes' half-century in 2017. In December we had a preview of the IF: Milton Keynes International Festival. Both feature Milton Keynes' large and diverse music, arts and culture scene.

And because it was a mainly business audience, they welcomed business community involvement because music, arts and culture can also be good for business. It puts Milton Keynes on the map by raising its profile in a positive way and makes Milton Keynes attractive to potential investors and to potential employees with all sorts of skills and talents. Having your business associated with major events generates good PR and can be a platform for entertaining clients and rewarding staff. And there's the good feeling that you are supporting your community.

I am looking forward to the IF and MK50 which will be stand-out celebrations following on from the success of the Rugby World Cup in 2015. But what about business supporting arts and culture, particularly those smaller grass roots and under-funded projects, beyond these big events?

After the talks the discussion turned to those businesses that already generously respond to individual requests for money from arts, culture and community groups. I suggested it could be better if they moved away from ad-hoc funding and towards giving as part of a business strategy. And if the contributions from many businesses could be pooled that combined generosity can be more effectively targeted and requests for help referred to a single contact, freeing up businesses to do what they do best.

That in turn led to a discussion around a possible arts and culture subsidy on the business rates, which has happened in South Bucks. Now that might be a step too far at the moment, but a model for collective donating and effective distribution of charity funds already exists in Milton Keynes and which could be used to attract businesses into supporting MK50.

Milton Keynes Community Foundation manages 'named funds' where companies or individuals pledge to give to a fund aimed at a specific sector or meeting a need they have identified. MK Business Leaders has one supporting social enterprise and entrepreneurship and it is topped up with the proceeds of the annual MK Business Achievement Awards, taking place again in March 2016.

I have already met MKCF chief executive Julia Upton to discuss whether this could happen. There are some hurdles to overcome but I am optimistic 2016 could see businesses in Milton Keynes more ready, more able and more willing to support the arts and culture scene across the city.
